Town Board Minutes September 9, 2025

The monthly town board meeting held on September 9, 2025, at 56 Geneva St. Dresden New York was called to order by Supervisor Peter Martini at 7:30PM.

Supervisor Martini led the pledge of allegiance.

August Minutes Ms. McGrath made a motion to approve 2^{nd} Mr. Henderson, Carried.

Abstract of vouchers - Supervisor Martini presented the abstracts for review.

Motion by Mr. Henderson 2^{nd} Ms. McGrath that the bills on the General A & B Accounts in the amount of \$6,112.04 be paid, carried by all.

Motion by Ms. McGrath 2^{ND} Mr. Henderson that the bills on the Highway DA & DB Accounts in the amount \$ 18,845.06 be paid, carried by all.

Motion by Ms. McGrath 2^{nd} Mr. Petersen, that the bill on the Water District 1 Account in the amount of \$ 534.15 be paid, carried.

Mr. Downs inquired as to who does final approval of payment on the bills from the Perry Point Culvert projects. Mr. Chambers stated that he submits the invoices and cancelled checks as proof of payment to the NYS DOT the final approval for payment to State.

He inquired if there will be an onsite engineer during construction. Mr. Chambers stated he is setting up a meeting on the slip line where these questions can be asked, possibly Thursday.

Supervisor introduced a Contract from Yates County for 2026 Pictometry. Motion by Mr. Petersen, $2^{\rm nd}$ Ms. McGrath authorizing the Supervisor to sign the 2026 Pictometry contract with Yates County, carried.

Highway Report Binghamton Boat Club gave permission for an access road to the culvert on Perry Point through their property. Heavy debris was cleared from the culvert and removed by the highway department.

Question on 4 wheelers or snow mobiles using this access road, the road goes nowhere, highway will put up cones as caution blocking the access road.

Last year Admar Equipment did road damage on Serenity Road. They gave the town 1-month free equipment as repayment for the damage. The town has use of an excavator for free for a month and is presently using it along Hopeton roadsides cleaning up trouble areas to prevent future flooding issues.

Code Report The short-term rental permits are almost at limit for the year. Received word that 2 more tree houses have been opened on Downey Road, these do not have final approvals by the Department of Health or Code Office. He will contact the owner. Construction is quiet.

Richard Willson appeared to update on the Yates County legislature.

In the 2026 Budget process. Ad hoc committee for Public Safety Building Project in need to contract with a project manager. Broadband finally has 26 customers signed up.

Discussion on shared sales tax, the county needs to refigure the formula for sharing, to increase the town and villages share.

Public transit, Mr. Willson was asked how many people use the system.

Unknown figure. Yates County is researching cost of contracting with Rochester Transit to replace Mozaic.

Gary McIntee asked if watershed Law is on website. He would like realtors to list that the town has a short-term rental law and availability of these short-term permits.

Mr. Downs informed the board that the newsletter is out, and he will be doing one more before his term is up in December.
